If so requested, the Bidding Documents can also be sent by post/courier services upon payment of additional cost of NRs. 10,000. However, the Employer will not be responsible for delay or non-delivery of the documents so sent.

- 5. Bidder could consult the concern authorities and will be clarify by means of phone, fax, email and other communication method whichever is available.
- 6. Sealed or electronic bids must be submitted to the Kirtipur Municipality Office, Devdhoka, Ward No. 2, by hand/courier or through PPMO website www.bolpatra.gov.np. on or before 12:00 hours on 31st day of Publication. Bids received after this deadline will be rejected. The bidder who has submitted their bid electronically must submit the original document as instructed by the employer.
- 7. The bids will be opened in the presence of Bidders' representatives who choose to attend at **14:00 hours** on **31**st day at the Kirtipur Municipality Office. If the bidder's representative does not choose to attend for opening, there will be no objection in opening the tender.
- 8. Bids must be valid for a period of **90 days** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of *following amount*, which shall be valid for **30 days** beyond the validity period of the bid.
