1. The Kirtipur Municipality, Office of the Municipal Executive towards the cost of Sagal tole - Salyansthane chowk - Chandragiri Road Improvement and intends to apply part of the funds to cover eligible payments under the Contract *for Sagal tole - Salyansthane chowk - Chandragiri Road Improvement KRM-02-2080/081*. Bidding is open to all eligible as per Section V of bidding document.
2. *The Kirtipur Municipality, Office of the Municipal Executive* invites electronic bids from eligible bidders for the construction of Sagal tole - Salyansthane chowk - Chandragiri Road Improvement under National Competitive Bidding – Single Stage Two Envelope Bidding procedures.
Only eligible bidders with the following key qualifications should participate in this bidding:
 - Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: **NRs 39,000,000**
 - Minimum Work experience of similar size and nature: **at least One (1) Contract, with a value of NRs 10,300,000.00**
3. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.

5. Bidder must submit their bid electronically should download the bidding documents for e-submission from PPMO's e-GP system www.bolpatra.gov.np/egp. Bidders, submitting their bid electronically, should deposit a non-refundable cost of bidding document NRs. 5000.00 in the Project's Rajaswa (revenue) account as specified below.

6. Pre-bid meeting shall not be held.
7. Electronic bids must be submitted through PPMO's e-GP system www.bolpatra.gov.np/egp or before 12:00, on 26th Poush 2080. Bids received after this deadline will be rejected.
8. The bids will be opened in the presence of Bidders' representatives who choose to attend at 14:00, on 26th Poush 2080 at the *Office of the Municipal Executive, Barkhahiti, Kirtipur*. Bids must be valid for a period of **90 days** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of **NRs 650,000**, which shall be valid for 30 days beyond the validity period of the bid.
9. If the last date of purchasing and/or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid and bid security shall remain the same as specified for the original last date of bid submission.
