1. **Kirtipur Municipality, Office of the Municipal Executive** invites sealed bids or electronic bids from Nepalese eligible bidders for the following Construction works.
2. A complete set of Bidding Documents may be purchased from the office *the municipal executive, Kirtipur Municipality, Devdhoka* by eligible Bidders on the submission of a written application, along with the copy of company/firm registration certificate, and upon payment of a non-refundable fee of Rs. 3000/- for each till 2077/05/07 during office hours.

Or

Bidder who chooses to submit their bid electronically may purchase the hard copy of the bidding documents as mentioned above or may download the bidding documents for e-submission from PPMO's Web Site [www.bolpatra.gov.np](http://www.bolpatra.gov.np)/egp.. Bidders, submitting their bid electronically, should deposit the cost(as specified above) of bidding document in the Project's Rajaswa (revenue) account as specified below and the scanned copy (pdf format) of the Bank deposit voucher shall be uploaded by the bidder at the time of electronic submission of the bids.

4. Pre-bid meeting shall not be held.
5. Sealed or electronic bids must be submitted to the office of *the municipal executive, Kirtipur Municipality, Devdhoka*, by hand or through PPMO website [www.bolpatra.gov.np](http://www.bolpatra.gov.np)/egpon or before 2077/05/08 on 12:00. Bids received after this deadline will be rejected.
6. The bids will be opened in the presence of Bidders' representatives who choose to attend at **14:00, 2077/05/08** at the office of *the municipal executive, Kirtipur Municipality, Devdhoka*. Bids must be valid for a period of **90 days** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in .pdf format in case of e-bid, amounting to a minimum of Rs. 4,50,000/-, which shall be valid for 30 days beyond the validity period of the bid.
7. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
