1. ***The Kirtipur Municipality, Office of the Municipal Executive has allocated funds*** towards the cost of Yoncho-Janasewa-Dahan-Bhajangal Road Improvement works and intends to apply part of the funds to cover eligible payments under the Contract ***for Yoncho-Janasewa-Dahan-Bhajangal Road Improvement works, KRM-07/2079/080***. Bidding is open to all eligible as per Section V of bidding document.
2. ***The Kirtipur Municipality, Office of the Municipal Executive*** invites electronic bids from eligible bidders for the construction of Yoncho-Janasewa-Dahan-Bhajangal Road Improvement works under National Competitive Bidding – Single Stage Two Envelope Bidding procedures.

Only eligible bidders with the following key qualifications should participate in this bidding:

- Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: NRs. 3,80,00,000/-
- Minimum Work experience of similar size and nature: ***at least One (1) Contract, with a value of at least NRs 1,02,33,000.00***

3. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.

5. Bidder must submit their bid electronically should download the bidding documents for e-submission from PPMO's e-GP system www.bolpatra.gov.np/egp. Bidders, submitting their bid electronically, should deposit a non-refundable cost of bidding document NRs. 5,000/- in the Project's Rajaswo (revenue) account as specified below.

6. Pre-bid meeting shall not be held.
7. Electronic bids must be submitted through PPMO's e-GP system www.bolpatra.gov.np/egpo on or before 12:00, on 1st Nov, 2022 (15th kartik, 2079). Bids received after this deadline will be rejected.
8. The bids will be opened in the presence of Bidders' representatives who choose to attend at 14:00, on 1st Nov, 2022 (15th kartik, 2079) at the office of ***Municipal Executive, Barkhahiti, Kirtipur***. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of NRs. 630,000/-, which shall be valid for 30 days beyond the validity period of the bid
9. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid and bid security shall remain the same as specified for the original last date of bid submission.
