- 5. Pre-bid meeting shall not be held.
- Electronic bids must be submitted to the office through PPMO's e-GP system www.bolpatra.gov.np/egp on or before 12:00, on 18<sup>th</sup> Ashoj 2081. Bids received after this deadline will be rejected.
- 7. The bids will be opened in the presence of Bidders' representatives who choose to attend at 14:00, on 18<sup>th</sup> Ashoj 2081. at the office of *the Municipality Executive, Barkhahiti, Kirtipur* Bids must be valid for a period of *90 days* from the date of bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of NRs. *625,000.00*, which shall be valid for 30 days beyond the validity period of the bid.
- 8. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the **bid and** bid security shall remain the same as specified for the original last date of bid submission.
