1. Kirtipur Municipality **has allocated funds or received a grant** from Ministry of Finance towards the cost of **Amritnagar - Maitry Nagar-Nepal Bhasa Academy Road Improvement** and intends to apply part of the funds to cover eligible payments under the same contract. Bidding is open to all eligible as per Section V of bidding document.
2. Kirtipur Municipality invites electronic bids from eligible bidders for the construction of **Amritnagar - Maitry Nagar-Nepal Bhasa Academy Road Improvement** under National Competitive Bidding – Single Stage Two Envelope Bidding procedures.

Only eligible bidders with the following key qualifications should participate in this bidding:

- Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: 4,30,00,000/- (Four Crore Thirty Lakh Only)
3. Minimum Work experience of similar size and nature: 2 projects, each with a value of at least NRs 2,30,00,000/- that have been successfully or are substantially completed and that are similar to the proposed works.
  4. Bidders need to download the bidding documents for e-submission from PPMO's e-GP system [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp) and submitting their bid electronically, should deposit the cost of bidding document NRS. 5,000/- in the Project's Rajaswa (revenue) account as specified below.

6. Pre-bid meeting shall not be held.
7. Electronic bids must be submitted to the office Kirtipur Municipality, Office of the Municipal Executive, Devdhoka-02 through PPMO's e-GP system [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp) on or before 12:00, on 2076/10/26. Bids received after this deadline will be rejected.
8. The bids will be opened in the presence of Bidders' representatives who choose to attend at 16:00 on 2076/10/26 at the office of Kirtipur Municipality, Office of the Municipal Executive, Devdhoka-02. Bids must be valid for a period of 90 **Days** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of Rs. 7,25,000/- (Seven Lakh Twenty Five Thousand only), which shall be valid for 30 days beyond the validity period of the bid.
9. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
